



DOT Report: 2017 CCF Expiring in August

The 2017 Federal CCF for Urine Collections will be expiring on August 31st. Be sure to only use the 2020 CCF beyond this date, as it will be the only accepted form without a Memorandum for the Record. If the 2017 version is used accidentally, a MFR will be required per DOT 49 CFR Part 40.205(b)(2).

Reminder: DOT Oral Fluids Regulations

Training with Lifeloc

At this time, Lifeloc is not providing a general Oral Fluids Collector certification or Oral Fluids Train the Trainer certification. Based on how the regulations are written, all training will be device specific and as of now, there are no approved devices. There are also no certified labs to test specimens. Additionally, it is unknown if the device manufacturers will require users to be certified directly by them, or if they will allow third party training. There are still a lot of loose ends which make the training aspect hard to accomplish. As soon as a list of approved devices is released and we understand the manufacturers requirements, we will be able to share the options Lifeloc will have available.

Things to Note

The Oral Fluids certification will require 5 error free mock tests on the specific device being used. If the collector will be using more than one device type, they will need to be certified on each device, much like EBTs. Both in-person and live webcam training will be permitted.

You can read more about the training requirements in 49 CFR § 40.35 (What training requirements must a collector meet for oral fluid collection?).

You can find the device requirements in **Appendix B**.

We encourage you to continue to reference DOT's publications and the many live webinars for information as things unfold. When testing devices are approved, we will keep you informed on which device(s) Lifeloc will be providing training on or where you can receive training.
